## Official Contest Prize Rules

### Member One – A Division of Virginia Federal Credit Union Roanoke GO Outside Festival October 3-19, 2025

1. No purchase is necessary. Entries limited to one per person.
2. Eligibility for Promotion: Participation is limited to U.S. residents. Winners must be at least 18 years of age. Current employees of Member One – A Division of Virginia Federal Credit Union, or Virginia Credit Union, and their family members and persons living in the same households of such employees are not eligible to enter. Promotion period begins Friday, October 3, 2025, at approximately 2:00 pm and ends at approximately 5:00 pm on Sunday, October 19, 2025, and runs during regular posted business hours each day. To submit an entry, participants should enter their name, email address, and phone number on the website forum. The winner will be randomly drawn and contacted by 11:59 pm on 10/22/2025.
