



## Official Contest Prize Rules

1. No purchase is necessary. Entries limited to one per person.
2. Eligibility for Promotion: Participation is limited to U.S. residents. Winners must be at least 18 years of age. Promotion period begins Saturday, January 20, 2024, at approximately 4:00 pm and ends at approximately 11:00 pm on Saturday, January 20, 2024. To submit an entry, participants will enter their name, address, email address, and phone number on the dedicated contest entry website forum on memberonefcu.com. One randomly-chosen winner will be drawn and notified directly after the drawing. The chosen winner will then be notified of his or her chance to take a shot on goal for a chance to win up to \$500.00. If the chosen winner is not present, another winner will be drawn for a chance to take a shot on goal for up to \$500.00.
3. Prize: Member One FCU will award \$500 to a present qualified contestant no later than February 28, 2024 in the form of a personal check issued to the contestant by Member One FCU.
